# **TERMS OF SERVICE**

#### OVERVIEW

- 1.1. The website (<a href="http://www.communitylearninghub.ca">http://www.communitylearninghub.ca</a>) is operated by Springboard.
- 1.2. This website is referred to variously in this document as "HUB Website"; or "this Website"; or "this Site"; "our Site"; "our Website"; or "the Service(s)"; or "Service(s)"; or "your Service(s)".
- 1.3. Throughout these Terms of Service, the terms "we", "us" and "our" refer to Springboard.
- 1.4. Springboard offers the HUB Website, including all information, tools and services available from this Site to you, the user, conditioned upon your acceptance of all terms, conditions, policies and notices stated here.
- 1.5. Please read these Terms of Service and the HUB Privacy Policy carefully before accessing or using our Website. By accessing or using any part of the Site, you agree to be bound by these Terms of Service and the HUB Privacy Policy. If you do not agree to all the terms and conditions of this agreement, then you may not access the Website or use any of its Services.
- 1.6. The headings used in this agreement are included for convenience only and will not limit or otherwise affect these Terms of Service.

# 2 WEBSITE TERMS

2.1. Where: (a) an individual is an employee of a non-profit agency, social sector service, or civic institution; and where (b) that organization is in the official business of delivering health promotion, harm prevention and/or harm reduction services to a vulnerable population; and where (c) that organization delivers its services to that population without profit; and where (d) an employee of that organization wishes to use the HUB Website for the exclusive purposes of his/her own professional development as a social service worker, and to deliver health-promotion/harm-prevention skill development programming to his/her organization's clients; and where (e) that employee covenants to deliver HUB programming to his/her organization's clients without charge whatsoever and in full accordance with his/her organization's policies and procedures and any federal, provincial, and municipal statutes, bylaws and regulations governing such practices; and where (f) that individual has accepted these Terms of Service and the HUB Privacy Policy; then that individual will be considered by Springboard "eligible" to access and utilize the HUB Website.



- 2.2. Notwithstanding Section 2.1, Springboard reserves the right to: (a) confirm the eligibility of any person applying for a HUB Website account; and (b) confirm or reconfirm the eligibility of any person already in possession of a HUB Website account; and (c) refuse Service to anyone for any reason at any time.
- 2.3. There is no direct cost for Ontario based non-profit agencies working with in-need/atrisk individuals to access the Community Learning HUB Website.
- 2.4. When applying to Springboard for a HUB Website account you must: (a) use your work contact information from the said organization described above in section 2.1.; and (b) not use a false e-mail address and/or pretend to be someone other than yourself; and (c) immediately inform Springboard should your tenure at the said organization terminate.
- 2.5. Login credentials issued to you by Springboard may only be used by you and not shared with other persons, even within the same organization.
- 2.6. You are responsible for maintaining the security of your HUB user's account and password. We are not liable for any claims, losses, damages, suits or proceedings relating to the sharing of your user account and/or password with others. You agree to notify Springboard immediately after you become aware of any unauthorized use of your user account and/or password, and to take such reasonable steps as are necessary to prevent any reoccurrence of such event.
- 2.7. You agree not to reproduce, duplicate, copy, sell, resell or exploit any portion of the HUB Website, use of the Service, or access to the Service or any contact on the Website through which the Service is provided, without express written permission by us.
- 2.8. You are responsible for all data uploaded to the HUB Website and all activity that occurs under your account.
- 2.9. You are solely responsible for the accuracy of any data you upload to the Site. We take no responsibility and assume no liability for the accuracy of data uploaded by you or any third party.

#### 3 HUB TEAM SELECTION

- 3.1. Once you have acquired individual log-in credentials for the HUB Website, you will have access to all of the Site's content; however, you will only be able to use the content <u>as an individual facilitator</u> and, as such, will not have any access to the HUB's "TEAM" functions. Without belonging to a HUB Team, you would not be able to deliver HUB programming to clients registered to the HUB Website by another facilitator (i.e.: a co-worker).
- 3.2. Facilitators belonging to the same HUB team share a single <u>Team Facilitator List</u> and a single <u>Team Client List</u>.
  - 3.2.1. A shared Team Facilitator List permits facilitators from the same HUB team to train on HUB programs together and co-facilitate HUB programming to clients.
  - 3.2.2. A shared Team Client List permits facilitators from the same HUB team to work with clients registered by fellow team facilitators
  - 3.2.3. A shared Team Client List also permits facilitators from the same HUB team to view the details of each client's participation in HUB programming that had been delivered by a facilitator affiliated with that team.
  - 3.2.4. A representative from Springboard will be contacting the executive director (or designate) for your agency to discuss whether or not your agency might benefit from HUB team affiliation and, if so, to determine which facilitators should belong to which HUB team.
  - 3.2.5. Please contact Springboard if you feel your HUB team designation is outstanding, or is not correct, or needs to change for some reason.

# 4 HUB TEAM SELECTION

- 4.1. We are not responsible if information made available on this Site is not accurate, complete or current. The material on this Site is provided for general information only and should not be relied upon or used as the sole basis for making decisions without consulting primary, more accurate, more complete or timelier sources of information. Any reliance on the material on this Site is at your own risk.
